### 1. INTRODUCTION

**This Privacy Policy was last updated on 05/24/2018**

The following Privacy Policy governs the privacy terms of the Websites located at [cryptoraven.com](http://cryptoraven.com) and [getrealikes.net](http://getrealikes.net) and the Services provided there.

We treat your privacy protection seriously and we take a reasonable care to meet all the legal requirements with the regard of privacy protection. We have made an effort to make this Privacy Policy clear and easy for you to understand.

This Policy sets what kind of information we collect, use, disclose, and protect, when you access and use the Website.

**By accessing and using our Websites and Services you agree to this Privacy Policy.**

**If you do not agree with this Privacy Policy, you need immediately stop using our Websites and Services.**

Certain words, phrases and terms in our Policy have meanings as described in 3. DEFINITIONS section of this document.

### 3. DEFINITIONS

In this Privacy Policy:

**Company**, or **Developers**, or **We** refers to CryptoRaven OÜ (14167590) - Private Limited Company

**Website** refers to the websites under the following address: [getrealikes.net](http://getrealikes.net) and [cryptoraven.com](http://cryptoraven.com)

**Services**, or **App**, or **Apps** refers to provided services and available applications, owned by the Company, also these available on the Websites to download

**You**, or **User**, or **Users** refers to any person who access and use the Websites or Services, or both of them.

**Personal Information** means information about an identifiable, living person, which you may provide to us in order to use some part of the Services. Personal Information can include either your name or email address, or both.

**Non-personal Information** means information that is not personally identifiable to you, and are publicly available and shared between you and others, and that we may automatically collect when you access our Services.

**Underlying System** means any network, system, software data, or material, that underlies or is connected to the Website or the Services, or is connected to the both of them

**Contact Form** means the way you can contact the Company, available on the Website under 'Contact us' tab

**including**, or similar words do not imply any limit.

## 4. INFORMATION WE COLLECT

When you only access our Websites, and do not use our Services and do not use "Contact Us" tab and do not contact us via our support email, we **ONLY collect your IP address and your user agent**. Any other of your data **ARE NOT** collected while you access our Websites.

These collected information are the information we obligatory receive every time you access our Websites and are the minimum crucial ones in order to protect us from cyber-attacks.

We receive, **but not collect or proceed**, the following:

- a. Automatic information, which is information we automatically receive from a Web browser or a device or from the both of them, from which you access the Website, such as an IP address of your computer/proxy server that you use to access the Internet, your Internet provider name, Web browser type, type of a mobile device and operating system.

When you use our Services, collect, use and store the following:

- a. your email address;
- b. your activity through the Services;
- c. when you make a purchase on our Services, we keep the date of the purchase, your payment email address and which in-app purchase have you chosen. We **do not** use or keep any of your sensitive financial information, such as number of your credit card.

We collect, use and store these information as long as we reasonable believe it is necessary to serves its purposes.

You agree that the data we collect can be stored in or outside your residential country or both, and we may use services from third party providers for such purposes.

### 5. PAYMENTS

When you make a payment for our Services, we need to proceed, collect and use the date of transaction, what type of product you have chosen and your payment email address.

We **do not** collect any of your confidential financial data, such as your credit card number.

The information we proceed, collect and use are the only crucial ones for us for such purposes as to deliver our Services and protect them from any fraudulent use.

Payments are possible to made only by third parties services listed on the Services. Although we take a reasonable care to choose the most reliable for us payment services, we can not guarantee how these services handle your personal data, since using their payment system is a part of their policies, which can not be adjusted or changed by us.

We can use your email address to update you about newest changes and updates of our Website and Services. You can always resign from receiving these mails by clicking “Unsubscribe” in these mails. We can also use your email address in case of important issues with your transaction or your use of the Services. Such mails are crucial to resolve any issues which may appear and to protect us and your purchased Services against fraudulent use, therefore, these do not have marketing purposes and you can not unsubscribe.

### 6. EMAIL CONTACT POLICY

When you wish to contact us, you need to input Personal Information, such as your name and email address to the Contact Form available on our Websites. If you contact us directly via our email address, you do not need to input Personal Information.

If we need to resolve any issue you have reported to us, we may ask you for additional information, such as your Orders lists on our Services. We **do not** ask for any confidential information.

These Information are crucial to us in order to provide you efficient support.

### 7. HOW WE USE COLLECTED INFORMATION

We can use collected information in order to:

e. to verify your compliance with our **Terms and Conditions**;

f. share your Non-personal Information and Personal Information with third parties to allow a merger, financing, acquisition, dissolution transaction, bankruptcy or sale, transfer or divestiture of all or portion of our assets or for all of these purposes. If such happens, we will notify you via banner add on our Website or similar online announcement, available on our Websites, prior the share;

g. we share your Personal Information, if we are legally required to do so by any legal processes (e.g a court order or subpoena or any other legal requests to disclose your Personal Information), law enforcement officials or government enforcement agencies, or if we need to investigate violations of or otherwise enforce any of our legal terms, or protect us from legal action or claims from third parties including you and necessary to protect the legal rights or personal safety of our Company, our users, employees, and affiliates, or we may share your Personal Information in case of all these cases.

## 8. SHARING YOUR DATA
